2. No other matters were discussed and meeting ended at 12.10 p..m











Paresh Sir is on the Advisory Board Member of a very large European Impact Fund.

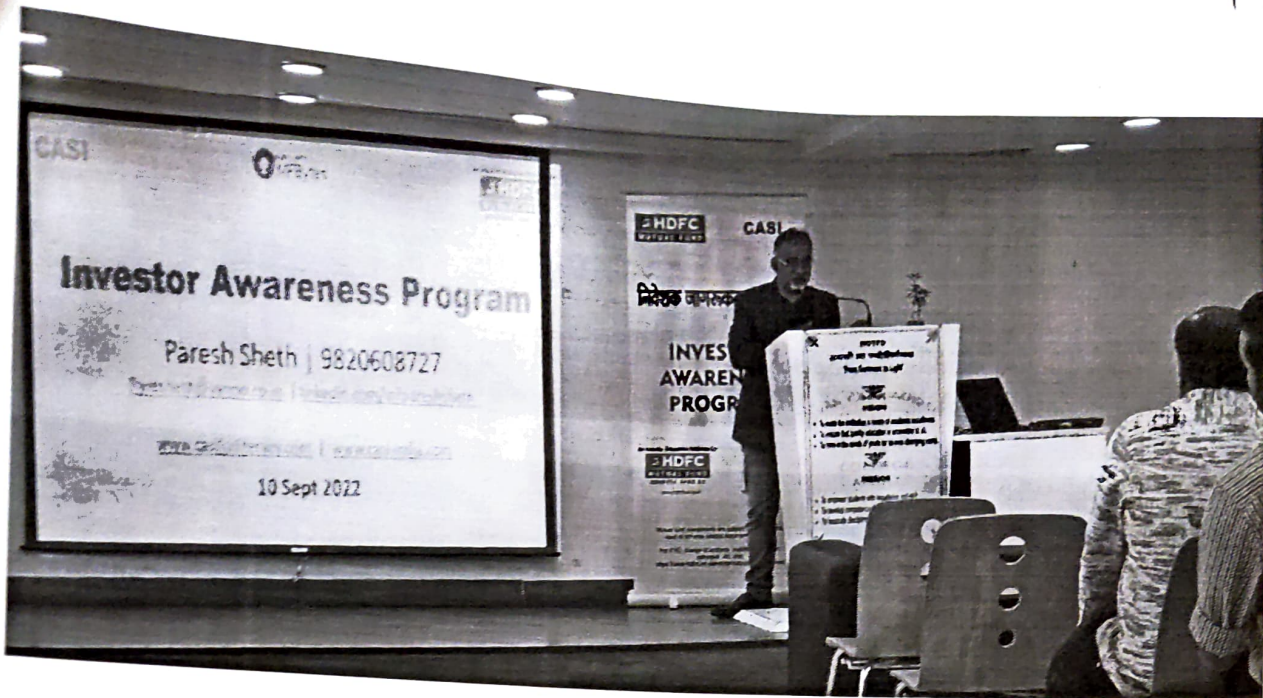
