

Pillai Institute of Management Studies and Research., represented by its Director, Dr. R Chandran and JVM'S Degree College & Junior College, Airoli, represented by its Principal Dr. Leena Sarkar hereinafter jointly referred to as Parties, and individually - Party, establish this General Agreement to foster cooperation in education and research.

- 1. Both parties agree to conduct activities to promote academic cooperation through training in soft skills and career development as knowledge partners and also faculty development programs.
- 2. This General Agreement shall be applicable to educational and research organization attached to each Party.
- 3. This agreement constitutes the entire agreement between the parties and all prior discussions, agreements and understandings, whether verbal or in writing, is merged in this agreement.

- 9. Modifications:No amendment, modification or waiver of any provisions of MoU shall be effective unless the same is in writing and signed or executed by both parties.
