**Yashwantrao Chavan College of Arts, Commerce & Science.**, represented by its Principal, Dr. Laxman Talnikar and **Jnan Vikas Mandal's Degree College, Airoli**, represented by its I/C Principal Dr. B.R. Deshpande hereinafter jointly referred to as Parties, and individually - Party, establish this General Agreement to foster cooperation in education and research.

1. Both parties agree to conduct activities to promote academic cooperation through training in soft skills and career development as knowledge partners and also faculty development programs.
2. This General Agreement shall be applicable to educational and research organization attached to each Party.
3. This agreement constitutes the entire agreement between the parties and all prior discussions, agreements and understandings, whether verbal or in writing, is merged in this agreement.

8. Each party shall designate a person or office to serve as liaison for implementing this Agreement.
9. Modifications: No amendment, modification or waiver of any provisions of MoU shall be effective unless the same is in writing and signed or executed by both parties.
