Sagar Kolhe, Deputy Chief Legal Aid Counsel, Thane Court was invited to deliver the lecture in college on 14th March, 2024 at the Seminar Hall of the college from 9 A.M. on the topic "**POSH ACT - Expected Behaviour in College & Workplace**".

Adv. Sagar Kolhe started the lecture with brief introduction of the constitutional fundamental rights & freedoms of all the citizens. He explained about the protection and punishment provisions under the different types of laws. He also put up the focus on the traditional cultural, social & legal view of society towards the women & explained the changed scenario of the legal environment by enforcement of different New Acts which are favourable for women protection & they can easily get justice.

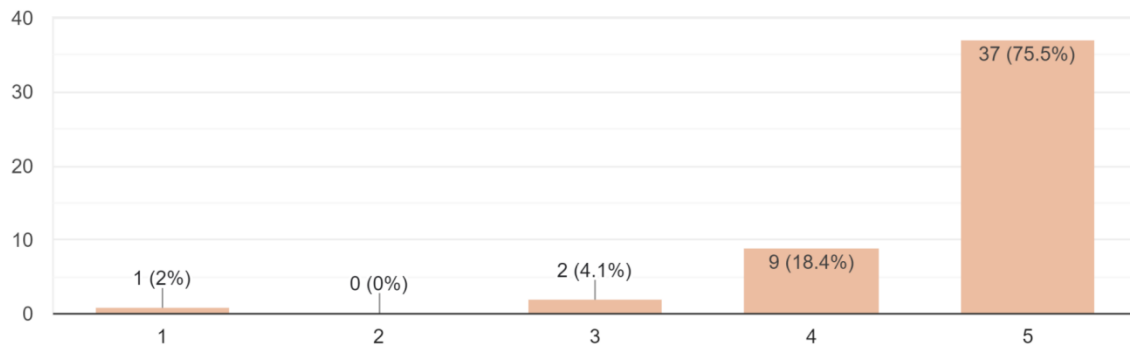

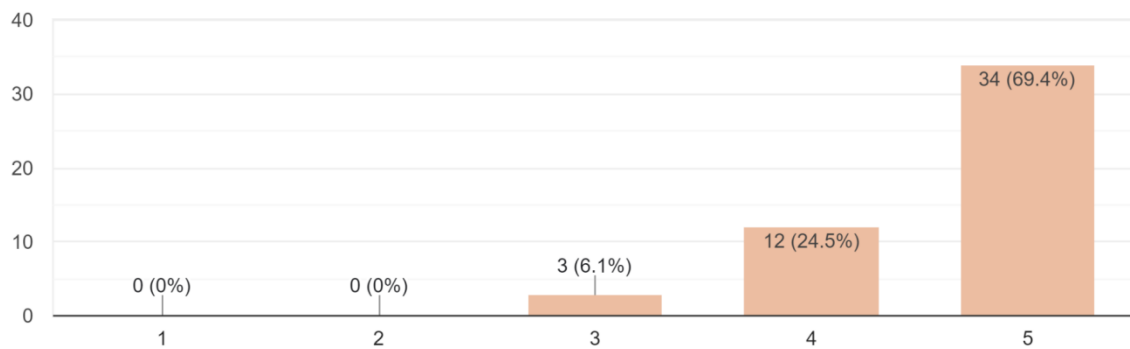

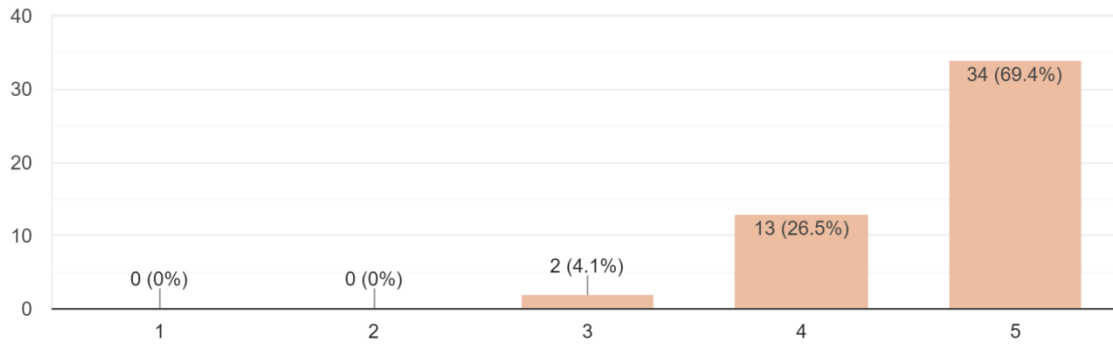
HOW WELL THE SESSION WAS ORGANISED.?

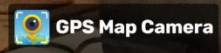
